Bidding documents may be purchased from the Central Bureau of Statistics, Thapathali, Kathmandu and within 30 days from the date of publication by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, business registration certificate, VAT registration certificate, tax clearing certificate/tax returns submission evidence for the fiscal year 2073/074 and manufacturers authorized dealer/distributer/sub-dealer/sub-distributer letter and upon payment of a non-refundable fee of NRs. 3000.00.
- 4. Sealed Bids must be submitted to Central Bureau of Statistics, Thapathali, Kathmandu before 12.00 noon on 31<sup>th</sup> days from the date of publication. Documents received after this deadline shall not be accepted.
- 5. Bids shall be opened in the presence of Bidders' representatives who choose to attend 2.00 pm on 31<sup>th</sup> days at the Central Bureau of Statistics, Thapathali, Kathmandu. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of NPR 1,50,000.00 which shall be valid for minimum 30 days beyond the bid validity period. If bidder wishes to submit the Cash Security, the cash should be deposited in Office code 27-391-01, Deposit Account No. 1201200001002524 at Nepal Rastra Bank, Thapathali Branch, Kathmandu and submit the receipt of the deposited amount of cash along with.
- 6. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
- 7. The purchaser reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
- 8. Bidders have to submit catalog (or certified copy) of (only those model) which they wants to offer.
- 9. After the delivery of Vehicle, supplier has to demonstrate.
- 10. A written declaration made by the bidder, with a statement that he/she is not ineligible to participate in the procurement proceedings; has no conflict of interest in the proposed procurement proceedings, and has not been punished for a profession or business related offense.
